

# MISSION SUMMARY REPORT - LAO PDR (31 May - 3 June 2023)

## **Background**

RUCaS aims to improve the value generated by investment in urban infrastructure by better integrating conventional large 'grey' infrastructure (e.g., levee banks, pipelines, treatment plants, roads, railways) with nature-based solutions (e.g., wetlands, mangroves, catchment protection, green walls, multifunctional parks and transport corridors). RUCaS program outputs will include case studies demonstrating application in different urban contexts and scales, as well as training in the tools and principles applied, and strategies to upscale NbS.

RUCaS mission 4 was undertaken to Lao PDR, Viet Nam and Cambodia to advance collaboration arrangements with government, civil society and multilateral agencies. Ground truthing case study sites with local stakeholders was a core focus.

### **Purpose**

This Lao mission had 4 objectives:

- Consider case study areas in Vientiane and Luang Prabang, and engage key stakeholders
- Define the RUCaS activities for each case study
- Advance relationships with Gender Equality, Disability and Social Inclusion (GEDSI) stakeholders and overall analysis for RUCaS and each case study
- Advance arrangements with the Lao Focal Point Ministry Ministry of Natural Resources and Environment (MONRE).

#### **Activities**

The mission included meetings with government agencies, development partners and GEDSI stakeholders. Meetings were opportunities to explore the current issues and pressure points affecting urban development in Lao cities, especially increased vulnerabilities created by extreme weather events (exacerbated by climate change) and wider catchment level developments. Site visits informed our understanding of case studies and allowed us to gather perspectives from local stakeholders.

- Meeting and site visit with GGGI With representatives from GGGI, we toured the Nong Org
  marsh and catchment in Vientiane, an important green space in the growing city of Vientiane,
  and an area for managing flood and intense rainfall. This site exemplifies how marshlands and
  natural drainage functions provide valuable services for local communities and the wider city.
- Meeting with Ministry of Natural Resources and Environment (MONRE) and Department of Climate Change Adaptation – We discussed MONRE becoming our Focal Point Ministry for Lao PDR. The Ministry's Department of Climate Change Adaptation will provide leadership for RUCaS with a wider Technical Advisory Group (TAG).











- Meeting with Department of Foreign Affairs and Trade (DFAT) Lao PDR Embassy We shared updates on the program, including related partnerships and development opportunities in Lao PDR.
- Meeting with Japan International Cooperation Agency (JICA) We discussed their work across Lao PDR, particularly their work related to water and preservation of the heritage values in Luang Prabang.
- Meetings with Lao Disabled People's Association (LDPA) and Gender and Development
   Association (GDA) We learned about their work and discussed how we can best incorporate
   inclusion principles into conceptual plans for local case studies and identify opportunities to
   upscale them for broader application throughout Lao PDR.
- Meeting with National University of Laos (NUoL) We discussed collaborating and coordinating
  work with the United Nations Environment Programme (UNEP) and MONRE on ecosystem-based
  adaptation and nature-based solutions program in Lao PDR.
- Site visit to Luang Prabang Luang Prabang's wetland ponds provide a range of services for communities. We investigated how nature-based solutions can enhance and extend the value of these traditional wetland ponds, which have been degraded by stormwater and grey and blackwater discharges from houses and businesses.
